Safety Forum Sessions – Guest Speakers

NSCC OHS Student Presentation - Introducing NSCC's Two-Year OHS Diploma Students

NS Department of Labour and Advanced Education – Harold Carroll, OHS Director

Harold Carroll is the Executive Director, OHS Division, NS Department of Labour and Advanced Education. He is married with three children. He graduated in 1983 from the University of New Brunswick with a BSc in Resource Management. After four years in the private sector, he moved to the provincial government to work with the NS Department of Natural Resources in a variety of different operational and management positions. In June, 2010, he received the NS Federal Council Award, issued in recognition of the contributions towards interdepartmental and intergovernmental collaboration with respect to advancing Sable Island for designation as a national park. In June, 2014, he received the Premier's Award of Excellence for development of Parks and Protected Areas Plan that was released in 2013. In February, 2015, he moved into his current role, as Executive Director of the OHS Division. Harold will provide an update on recent activities and expectations for the coming year.

John Hollohan – “Safety Leadership: The Influence on Culture”

John Hollohan has worked in the industrial safety and health profession for more than 23 years. He is the Corporate Director of Safety with Emera, Inc. As a member of the senior management team, he is accountable for strategic safety leadership within Emera's diversified energy business throughout Canada, United States and the Caribbean. Mr. Hollohan holds degrees from Memorial University and Ryerson University as well as an Organizational Development certificate from Queens University. He holds the designation of Canadian Registered Safety Professional (CRSP), a nationally recognized safety designation. He resides in Halifax, NS, with his wife Karen and dog, Dudley, who both wish he did not travel so much for work.

David Chiasson – The new CSA Office Ergonomic Standard

Dave Chiasson - In 1996 Dave graduated from Dalhousie University with a Master of Science degree in Kinesiology with specialization in Ergonomics. He worked with The Province of Nova Scotia as an Ergonomist for five years before starting his own company, Ergonomic Systems Associates, in 2001. In 2002 he became a Board Certified Professional Ergonomist as awarded by the Board of Certification in Professional Ergonomics (BCPE). For the past 18 years Dave has been very fortunate to have worked with hundreds of private corporations and government customers throughout Canada. Along the way he has completed well over ten thousand office ergonomics assessments and workshops. Dave lives in Dartmouth, Nova Scotia.

The Canadian Standards Association (CSA) has developed a new standard for workplace ergonomics that clearly states that office ergonomics should be part of any Occupational Health and Safety Program. The standard recognizes that employee training in the use of their equipment is an important part of minimizing health risks. So, please attend this presentation that will highlight specific parts of the standard to let you know about what constitutes a proper task chair, a sit/stand workstation and finding the right balance of postural variety through the workday. Find out what the standard has to say about the use of multiple monitors, non-traditional workspaces such as vehicles and home offices as well as information on the use of mobile devices and laptops. While this standard is not legally mandatory, provincial OHS legislation places responsibility on employers for providing an environment that protects the health and safety of employees. Applying this standard will enhance user health, safety, and well-being and will provide guidelines for employers to optimize system performance in order to prevent occupational injuries and illnesses.

Bridget Brownlow – “Electronic Communication”

Bridget Brownlow is the Conflict Resolution Advisor for Saint Mary's University. She holds a Master's degree (History) and is a certified conflict resolution specialist with over 20 years of extensive experience in organizational conflict management. Her expertise is focused on delivering a wide range of appropriate dispute resolution services, training and education designed for students, faculty, staff and unions at all levels within the university. For the past fourteen years, Bridget has been the Senior Coordinator for an international conflict resolution initiative in Northern Ireland. This involves working directly with students, faculty and staff in the development and implementation of peace education programs in collaboration with Peaceful Schools International and Saint Mary's University. Bridget is currently the President of Peaceful Schools International and teaches part-time in the Department of Political Science, Department of Irish Studies as well as the Faculty of Education at Saint Mary's University.

There are many benefits associated with electronic communication, which is increasingly being used for personal as well as business communications. However, our growing reliance on e-mail and other forms of electronic communication has underscored its weakness – that it can contribute to unnecessary conflict, especially within organizational settings. Electronic communication is an impersonal medium that can help foster miscommunication, misunderstanding, mistrust and confusion. Moreover, attempts to resolve conflict using electronic communication routinely result in matters only being made worse. At Saint Mary's University, addressing and preventing conflict arising from electronic communication is part of the violence prevention program.
